### **Event Details**

Entering its 2<sup>nd</sup> year, this event is the *primary* fundraiser for CASA Jefferson

benefiting the children of Jefferson Parish in foster care served by our program.

To incorporate the addition of spirits tastings this year, the name of this annual event has been updated to *Sip Sip Hooray!* for CASA Jefferson. The complementary combination of tastings of both wine and spirits has a broader appeal, so a larger audience is anticipated at our 2020 event.





The first wine tasting event in 2019 sold nearly 200 tickets for the event with net proceeds exceeding \$38,000.

The goal for our 2020 event is to sell 250 tickets or more. Primarily through *partnerships* as well as through donations, our goal is to increase the net proceeds to reach \$100,000 or more.

### The 2020 theme is Sip Sip Hooray! for CASA Jefferson

What to Expect: A lively and fun event including wine tasting, bourbon, rum, vodka and gin tastings, small bites, both live and silent auctions, and live music.

# Court Appointed Special Advocate

### Why support Sip Sip Hooray! for CASA Jefferson?

At a direct program cost of over \$3,000 annually per child, an annual budget of over \$700,000 is required to support the current program in Jefferson Parish alone. Partnerships are the only way CASA Jefferson can reach its goal for each and every Jefferson Parish foster child to have a CASA assigned to them.

Annually, approximately 25% of Jefferson Parish foster children do not get a CASA. Through your partnership with CASA Jefferson, your donation will facilitate the event and drive additional support and donations from those attending the event, all with the goal to have 100% of these children represented by a CASA.

EACH YEAR in Jefferson Parish, more than 250 children are placed in foster care under the jurisdiction of the Jefferson Parish Juvenile Court, because they were abused and or neglected in their own homes. Over 20 children are waiting to be assigned to a CASA volunteer today!

With an assigned CASA, a child will spend significantly *less time* in the foster care system and is *twice as likely* to find a safe, permanent home. Children with a CASA volunteer have a voice in court – have someone



that steps up for them and ensures that their best interest is heard!
